Coverage Features

Employee Theft/Client Coverage

- No "manifest intent" language
- Broad definition of Employee- includes volunteers, leased employees, seasonal employees, and student interns
- Blanket ERISA Fidelity coverage
- Investigative Costs coverage (\$25,000 sub-limit)
- Loss Reporting Threshold (25% of applicable deductible)
- Prior Dishonesty Cancellation Clause per employee threshold of \$25,000
- Coverage for client's property

Bell Endorsement

- Includes \$50,000 limits each for Business Travel Accident Benefit, Donation Assurance, Emergency Real Estate Consulting Fee, Identity Theft Expense, Image Restoration and Counseling, Key Individual Replacement Expenses, Kidnap Expense, Terrorism Travel Reimbursement, and Workplace Violence Counseling. \$25,000 limits for each Conference Cancellation, Fundraising Event Blackout, Political Unrest (\$5,000 per employee), Temporary Meeting Space Reimbursement, and \$1,500 Travel Delay Reimbursement

Crisis Management Enhancement Endorsement

- \$25,000 limit for crisis management emergency response expenses incurred because of an incident giving rise to a "crisis"

Documents Required for Proposal

- Completed, signed, and dated Crime Protection Plus application
- Eligible risks include most commercial (non-financial institution) accounts, including both for profit and non-profit
- Application available online (include audited financial statements for limit requests of \$1M or higher)
- Third party application required if Third Party coverage is requested
- Supplement may be required depending upon class of business (see website list)
